### **Leaving A Legacy**

Leaving a Legacy enables you to maximize the benefits of philanthropy while completing your financial and estate planning. Recognizing that different people have different financial and estate planning needs, York County Community Foundation will work with you and your advisors to help to develop the best plan for you.

#### ***Bequests***

***Bequests may be created by will or by revocable and irrevocable trusts and may be designated in a number of ways. They may be funded by a specific amount of money, a percentage of your estate, or a particular asset, such as stocks or real estate. York County Community Foundation may be named as the recipient of all or part of your estate, or as contingent beneficiary in the event beneficiaries do not outlive you.***

Creating a meaningful and financially sound estate plan is of critical importance to all of us, regardless of the size of our estate. It is our final opportunity to assure that our wishes are carried out with regard to the assets we have accumulated during our lifetime, our family's future, and the future viability of the charitable organizations we care about and have supported during our lifetime.

### ***Life Income Gifts***

***Another option to consider is a life income gift, which is an excellent way to supplement one's income during retirement, while also making a charitable gift. Or you may wish to provide for a loved one after your death while naming a favorite charity as the final beneficiary.
